### SECTION 4 - FIRST-AID MEASURES

#### 4.1 Description of first aid measures

**General advice:** Consult a doctor and show this safety data sheet.

#### **7.1 Precautions for safe handling:**

Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

**7.2 Conditions for safe storage, including any incompatibilities:** Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Recommended storage temperature is 2 - 8 °C. Moisture sensitive.
